CIRCULAR

The Syndicate at its meeting held on 14-02-2023 has considered and interalia adopted the content in the Sl.No.11 of the G.O.Ms.No.178, Finance (Budget General – I) Department dated: 20-06-2023 with regard to the restoration of Leave Travel Concession to the Government Employees which was stopped during Covid-19 Pandemic based on the G.O.Ms.No.249, Finance (Budget General-I) Department dated: 21-05-2020.

In this regard, it is informed that the Leave Travel Concession for the previous block year of 2017-2020 has ceased on 31-12-2020 and that the 2021-2024 block year officially begins w.e.f. 01-01-2021. However, due to introduction of certain measures by the Government of Tamil Nadu to curtail the expenditure which prevailed in the University of Madras during Covid-19 Pandemic the Budget of LTC for the year 2020-2021, 2021-2022 and 2022-2023 has not been allocated, as a result sanctioning of the LTC to the employees has been stopped.

Now, in view of the issuance of G.O.Ms.No.178, Finance (Budget General-I) Department dated: 20-06-2022, the Syndicate of the University of Madras has allocated the Budget for LTC for the financial year 2023-2024 and hence the provision of availing LTC is restored and now implemented to the employees of the University of Madras both teaching and administrative cadres.

In this context, it is further informed that the Leave Travel Concession for the block year 2021-2024 shall be availed by the employees of the University of Madras by submitting necessary application form which is appended in this circular.
